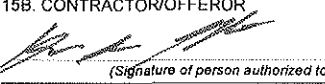
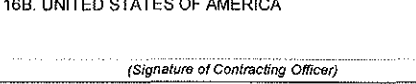

The purpose of this modification to Inter-Governmental Service Agreement (IGSA) DROIGSA-10-0002 is to incorporate the adjusted rates as a result of Contract Specific Wage Determination 2011-0218, Number Revision 3, Dated 12/07/2011. The rate adjustments are as follows;

- 1) Bed day Rate has increased from \$95.20 by \$5.75 to \$100.95.
