The City hereby releases, relinquishes and discharges the County, its officers, agents and employees, from all claims, demands, and causes of action of every kind and character, including the cost of defense thereof, for any injury to, including death, of person (whether they be third persons, contractor, or employees of either of the parties hereto), any loss of or damage to property (whether the same be that either of the parties hereto or of third parties) caused by or alleged to be caused, arising out of, or in connection with the City's actions under this Agreement, whether or not said claims, demands and causes of action in whole or in part are covered by insurance, and environmental risks, including direct and indirect costs associated with remedial action (including the repair, replacement or restoration of improvements and equipment, and monitoring and other closure requirements imposed by any governmental entity), fines, assessments, penalties, forfeitures, judgments, settlements, orders, equitable relief, suffered, paid, incurred by, or sought from City in connection with, in whole or in part, or arising or allegedly arising, directly or indirectly out of non-compliance with any environmental law, whether or not said claims, demands and causes of action in whole or in part are covered by insurance.

The County will reimburse the City \$5,000 for costs related to any remedial work performed by the City on the Property.
