She continues to serve the community through Palm Valley Lutheran Church, the Justice Council, Round Rock Kiwanis, Williamson County Life Steps Board of Directors, and various Chambers of Commerce of Central Texas cities.



WHEREAS, Mrs. Rabb and family have had a very positive impact on Williamson County through their many years of service to our community.




