

INTERLOCAL AGREEMENT

Pursuant to Texas Government Code, Chapter 791, the City of Liberty Hill, Texas ("City"), wishes to enter into an Interlocal Agreement ("Agreement") with the Williamson County Road & Bridge, acting by and through Williamson County, Texas ("County"), for the reasons set forth below.

A description of the services to be performed, location of work site and the estimate of labor and costs is attached hereto as Exhibit "A" and incorporated herein by reference.

Upon completion of the services described in Exhibit "A", the County will invoice the City for the total actual costs of all labor and equipment used to perform the services. The City must pay the County within thirty (30) calendar days from the date of the invoice.

The parties expressly agree that nothing in this Agreement adds to or changes the liability limits and immunities for a governmental unit provided by the Texas Tort Claims Act, Chapter 101, Civil Practice and Remedies Code, or other law. The parties expressly agree that, in the execution of this Agreement, neither party waives, nor shall be deemed hereby to waive, any immunity or defense that would otherwise be available to it against claims arising in the exercise of its powers or functions or pursuant to the Texas Tort Claims Act or other applicable statutes, laws, rules, or regulations.

Either party has the right to terminate this Agreement, in whole or in part, for convenience and without cause, at any time upon ten (10) days' written notice to the other party.

IN WITNESS WHEREOF, The parties have duly executed and delivered this Agreement on the date set forth above, to be effective as of the 11th day of April, 2016.
