The Performing Party agrees to appear at location of Receiving Party, on dates that are mutually acceptable to both parties, to conduct two 16 hour HEP209 (front end loader) classes (four consecutive days) and one 32 hour HEP208 (Motor Grader) class (four consecutive days). Performing Party will provide competent instructor, related curricula, training material, sign in roster, certificates for successful candidates and skills evaluations for all participants.

The receiving party will provide adequate facilities for classroom portions of training and a field location that has been cleared (811 One Call) for the presence of buried utilities. Receiving Party will also provide 1 operational machine, that passes safety inspection, for each 2-3 attendees. Receiving Party has sole responsibility for fuel, lube, maintenance and the operational readiness of each machine. Start and end times of class will be mutually agreed upon prior to commencement of classes
