

## AMENDMENT

This amendment ("Amendment") is made this 16 day of December 2016 by and between Tyler Technologies, Inc. ("Tyler") and Williamson County, Texas ("End User").

WHEREAS, Tyler and End User are parties to a certain End User License Agreement and Professional Services Agreement dated September 14, 2011 ("Agreement"); and

WHEREAS, Tyler and End User desire to amend the Agreement to add the Licensed Software and related Professional Services and Maintenance and Support Services detailed in the attached Schedule 1.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and End User agree as follows:

1. The Licensed Software detailed in the attached Schedule 1 is hereby added to the Agreement. Upon the Effective Date of this Amendment, End User shall pay Tyler the License Fees for the Licensed Software added hereby.
2. Upon the Effective Date of this Amendment, the Licensed Software added hereby shall become subject to the current Maintenance and Support Services Agreement and End User shall pay the Maintenance and Support Fees detailed on the attached Schedule 1 on a prorated basis through the end of End User's current term, and thereafter, annually in advance in accordance with the current Maintenance and Support Services Agreement.
3. The Professional Services detailed on the attached Schedule 1 are hereby added to the Agreement. Professional Services fees, plus allowable expenses, shall be invoiced to End User as delivered, on a time and materials basis.
4. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
5. All other terms and conditions of the Agreement shall remain in full force and effect.
