## ORDER CREATING WILLIAMSON COUNTY ELECTION PRECINCT 202

Precinct 201 has 5,514 active registered voters. Precinct 201 violates section 42.006 of the Texas Election Code because it contains more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

Recommendation is made to split Precincts 201 and 204 and create Precinct 202 as graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

Precinct 201 4,674 Precinct 204 4,419 Precinct 202 1,316

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

Precinct 202 shall be created from the northern portion of current <u>Precinct 201</u> north of Whitestone Boulevard. The precinct will also gain the northern portion of current <u>Precinct 204</u> north of Whitestone Boulevard. The designated polling place for Precinct 202 shall be Holiday Inn Express, 1605 East Whitestone Boulevard, Cedar Park.

- THENCE, southerly, along the center of Ronald Reagan Boulevard to the north edge of Caballo Ranch subdivision extended;
