

**ORDER CREATING  
WILLIAMSON COUNTY ELECTION PRECINCTS 489 AND 490**

Precinct 424 has 6,288 active registered voters. Precinct 488 has 5,138 active registered voters. These precincts violate section 42.006 of the Texas Election Code because they contain more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

Recommendation is made to split Precincts 488, 424, and 402 to create Precincts 489 and 490 as graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

Precinct 402	4,498
Precinct 424	3,546
Precinct 488	2,297
Precinct 489	4,268
Precinct 490	1,545

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

**Precinct 489** shall be created from the southern portion of current Precinct 488 south of Forest Creek Drive. The precinct will also gain the southwest portion of current Precinct 424 following the current Round Rock Independent School District boundary and the current City of Round Rock Boundary. The designated polling place for Precincts 489 and 488 combined shall be Ridgeview Middle School, 2000 Via Sonoma Trail, Round Rock.

**Precinct 490** shall be created from the northwest central portion of current Precinct 424 not within Round Rock Independent School District. The precinct will also gain the western portion of current Precinct 402 not within the current boundary of City of Hutto. The designated polling place for Precinct 490 shall be Golf Club at Star Ranch, 2500 FM 685, Hutto. The designated polling place for Precinct 424 shall remain Forest Creek Elementary School, 3505 Forest Creek Drive, Round Rock. The designated polling place for Precinct 402 shall remain Hutto City Hall, 401 West Front Street, Hutto.

Williamson County, Texas**

**BEGINNING at the intersection of US Highway 79 and South Farm to Market Road 1660;**

**THENCE, southerly, along the center of South Farm to Market Road 1660 to its intersection with Old County Road 137;**

**THENCE, southerly, along the center of Old County Road 137 to its intersection with County Road 135;**

**THENCE, westerly, along the center of County Road 135 to its intersection with Coyote Trail;**

**THENCE, northerly, along the center of Coyote Trail to the southern boundary of City of Hutto;**

**THENCE, westerly, along said boundary to Comal Run;**

**THENCE, northerly, along the center of Comal Run to the southern boundary of Census Block 48491020874013;**

**THENCE, westerly, along said boundary to the southern boundary of Census Block 484910208074014;**

**THENCE, westerly, along said boundary to the southern boundary of Census Block 484910208071002;**

**THENCE, westerly, along said boundary to Chris Kelly Boulevard;**

**THENCE, northerly, along the center of Chris Kelly Boulevard to the western boundary of the City of Hutto;**

**THENCE, northerly, along said boundary to its intersection with US Highway 79;**

**THENCE, easterly, along the center of US Highway 79 to the place of the BEGINNING.**

**Election Precinct No. 424  
Williamson County, Texas**

**BEGINNING at the intersection of Red Bud Lane and Brushy Creek;**

**THENCE, easterly, along Brushy Creek to the eastern boundary of Round Rock Independent School District;**

**THENCE, southerly, along said boundary to the northern boundary of City of Round Rock;**

**THENCE, easterly, along said boundary to the northern boundary of Round Rock Independent School District;**

**THENCE, easterly, along said boundary to the eastern boundary of Round Rock Independent School District;**

**THENCE, southerly, along said boundary to the southern boundary of City of Round Rock;**

**THENCE, westerly along said boundary to the center of Red Bud Lane;**

**THENCE, northerly, along Red Bud Lane to the place of the BEGINNING.**

**THENCE, westerly, along the center of Forest Creek Drive to its intersection with Dry Branch;**

**THENCE, northerly, along the center of Dry Branch to Brushy Creek;**

**THENCE, northerly, along the center of Brushy Creek to the western boundary of Census Block  
484910215083037;**

**THENCE, northerly, along said boundary to the western boundary of Census Block 484910215083038;**

**THENCE, northerly, along said boundary to the center of East Palm Valley Boulevard;**

**THENCE, easterly, along the center of East Palm Valley Boulevard to the place of the BEGINNING.**

**Election Precinct No. 489  
Williamson County, Texas**

**BEGINNING at the intersection of Gattis School Road and the common line between Williamson and Travis County;**

**THENCE, easterly, along the center of Gattis School Road to its intersection with Dyer Branch;**

**THENCE, northerly, along the center of Dyer Branch to its intersection with Forest Creek Drive;**

**THENCE, easterly, along the center of Forest Creek Drive to its intersection with Red Bud Lane;**

**THENCE, southerly, along the center of Red Bud Lane to the southern boundary of City of Round Rock;**

**THENCE, easterly, along said boundary to the eastern boundary of Round Rock Independent School District;**

**THENCE, southerly, along said boundary to the common line between Williamson and Travis County.**

**EXHIBIT F**

**Election Precinct No. 490  
Williamson County, Texas**

**BEGINNING at the intersection of the western boundary of Hutto Independent School District and the common line between Williamson and Travis County;**

**THENCE, northerly, along the western boundary of Hutto Independent School District to its intersection with East Palm Valley Boulevard;**

**THENCE, easterly, along the center of East Palm Valley boulevard to the western boundary of City of Hutto;**

**THENCE, southerly, along said boundary to its intersection with Chris Kelley Boulevard;**

**THENCE, southerly, along the center of Chris Kelley Boulevard to the Farm to Market 685;**

**THENCE, southerly, along the center of Farm to Market 685 to the common line between Williamson and Travis County.**
