WHEREAS, the CCA has undergone a legal name change and desires to change its name as reflected in the Agreement; and

- 4. The December 2012 subcontracting of this Agreement to CoreCivic's wholly-owned subsidiary remains in effect. References to "CCA of Tennessee, LLC" are replaced with "CoreCivic of Tennessee, LLC"
- 5. All other terms of the Agreement not amendment herein shall remain the same.


