

CONTRACT AMENDMENT NO. _1____TO WILLIAMSON COUNTY CONTRACT FOR ENGINEERING SERVICES

WILLIAMSON COUNTY ROAD BOND PROJECT: SEWARD JUNCTION SOUTHWEST ("Project")

THIS CONTRACT AMENDMENT NO. 1 to Williamson County Contract for Engineering Services is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and K Friese + Associates, Inc. (the "Engineer") and becomes effective as of the date of the last party's execution below.

WHEREAS, the County and the Engineer executed the Williamson County Contract for Engineering Services dated effective April 9, 2015 (the "Contract");

WHEREAS, pursuant to Article 14 of the Contract, the terms of the Contract may be modified by a written fully executed Contract Amendment;

WHEREAS, the "Compensation Cap" under Article 5 of the Contract limits the maximum amount payable under the Contract to \$ 350,000.00; and,

WHEREAS, the Rate Schedule in Exhibit D of the Contract are limited to the rates noted in said Exhibit D: and.

WHEREAS, it has become necessary to amend the Contract.

AGREEMENT

NOW, THEREFORE, premises considered, the County and the Engineer agree that the Contract is amended as follows:

- I. The Compensation Cap under Article 5 of the Contract is hereby increased from \$ 350.000.00 to \$ 400.000.00.
- II. The hourly Rates in the original Exhibit D of the Contract are hereby amended as shown in the attached revised Exhibit D (must be attached).

All other terms of the Contract are unchanged and will remain in full force and effect.



Existing Facility

New three and six lane roadway with HMAC or PCC pavement, concrete ribbon curb, curb and gutter, roadside drainage with 150-feet right-of-way. This project utilizes Williamson County and TxDOT 2014 standards.

1. <u>CONSTRUCTION PHASE SERVICES</u>

- a. REQUESTS FOR INFORMATION RFIs (20 assumed):
 - Attend site visits and/or meetings to gather data and information for RFI responses.
 - Respond to Contractor RFIs and provide design clarifications, additional information, and additional data to the GEC as required.
- b. REVIEW CONTRACTOR SUBMITTALS & SHOP DRAWINGS (20 assumed):
 - Review Contractor submittals and shop drawings received from the GEC. Shop
 drawings will be reviewed for general conformance with the plans and specifications and
 will include providing stamped concurrence, exceptions or resubmittal notations to the
 Contractor.
- c. PLAN REVISIONS FOR FIELD CHANGES (20 sheets assumed):
 - Engineer will provide minor revisions to plans in order to address differing site
 conditions, third party accommodation, or other owner directed changes. Revisions to
 plans will include revision clouds around any changes, will include descriptions and
 quantities of changes, CAD files, and will be sealed by a professional engineer.
- d. ATTEND FIELD & MONTHLY PROGRESS MEETINGS (4 assumed):
 - Engineer will attend meetings at the project site and progress meetings at Williamson County representative office or Project Office.
 - Provide periodic inspection (2 hours per visit) during construction to address questions on interpretation of plans and review the construction work related to adherence to the design plans.

2. DELIVERABLES

a. All contract documents, including hard copies and electronic files, shall be turned over to the County at each milestone and at the completion of the project. Documents shall be posted to the County's project management database as requested.
