THIS CONTRACT AMENDMENT NO. 4 to Williamson County Contract for Engineering

Services is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and <u>Halff Associates, Inc.</u> (the "Engineer") and becomes effective as of the date of the last party's execution below.			
WHEREAS, the County and the Engineer executed the Williamson County Contract for Engineering Services dated effective <u>June 24, 2014</u> (the "Contract");			
WHEREAS, pursuant to Article 14 of the Contract, the terms of the Contract may be modified by a written fully executed Contract Amendment;			
WHEREAS, the "Compensation Cap" under Article 5 of the Contract limits the maximum amount payable under the Contract to \$ 770,000; and,			
WHEREAS, the Rate Schedule in Exhibit D of the Contract are limited to the rates noted in said Exhibit D; and,			
WHEREAS, it has become necessary to amend the Contract.

I. The Compensation Cap under Article 5 of the Contract is unchanged.
