



PUBLIC INVOLVEMENT SERVICES AGREEMENT

This Amendment No. 1 to Public Involvement Services Agreement (“Amendment No. 1”) is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the “County”) and Buie & Co., LLC, a limited liability company organized and existing under the laws of the State of Texas, (the “Firm”).

WHEREAS, the County and the Firm executed the Public Involvement Services Agreement effective as of May 27, 2016 (the “Agreement”);

WHEREAS, the Not to Exceed Amount in Section 4.3 was not completed upon execution of the Agreement;

WHEREAS, the hourly rates set out in Section 4.4 of the Agreement do not contain the rates for the Firm's subconsultants; and,

WHEREAS, it has become necessary to amend the Agreement.

NOW, THEREFORE, premises considered, the County and the Firm agree the Agreement is amended as follows:

I. Section 4.3 of the Agreement shall be amended as follows:

The maximum amount payable for the performance of all Services and the reimbursement of all expenses under this Agreement, without written modification, must not exceed \$1,000,000.00 ("Not to Exceed Amount"). Any amounts paid or payable will be paid pursuant to a validly issued Work Authorization or Change Requests related thereto. In no event may the aggregate amount of compensation and reimbursement authorized under Work Authorizations and Change Requests exceed the Not to Exceed Amount.

II. Section 4.4 of the Agreement shall be amended as follows:

Note 2: Hourly rates are applicable during the entire term of this Agreement.

III. Each party represents and warrants that it has due power and lawful authority to execute and deliver this Amendment No. 1 and to perform its obligations under the Agreement; and, furthermore, the Agreement and this Amendment No. 1 are the valid, binding and enforceable obligations of such party.

IV. All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.
