(Additional Funding Details)**

WHEREAS, the Parties mutually agree to the public purpose of having Emergency Medical Services ("EMS") ambulances and crews in the Williamson County Emergency Services District #7 ("ESD #7");

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the undersigned Parties further agree as follows:

I.

Financial Contribution by County for Construction of Ambulance Bay(s):

The County agrees to pay the *total* amount of \$300,000.00 toward the construction costs of necessary ambulance bay(s) and ESD #7 shall provide any necessary improvements to the EMS sole occupied space to prepare same as move-in ready.

II.


Schedule of Payments: The County's shall pay one half of the total project cost (\$150,000.00) at the start of construction and the remaining half (additional \$150,000.00) upon completion of the project. **The parties understand that the costs are *estimated* at this time and subject to final adjustments and billing from third-party contractors or vendors; however, the parties will act in good faith to limit any changes to increase costs and with regard to abiding by the anticipated payment of The County's contemplated funding not-to-exceed amount of \$300,000.00. Billing will be**

made at the start of the project and at the completion of the project by ESD #7 pursuant to the schedule set forth herein, and payment for any invoice is due within thirty (30) days of receipt by The County. Payment for goods and services shall be governed by Chapter 2251 of the Texas Government Code. The payment amount set forth herein may not be modified or amended other than by a written instrument executed by both parties.
