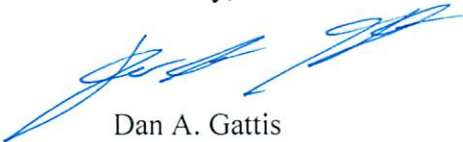
CAMPO Transportation Policy Board and Executive Director Mr. Ashby Johnson:

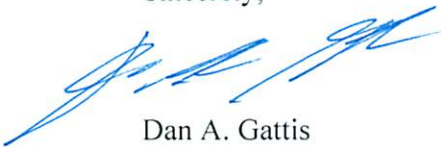

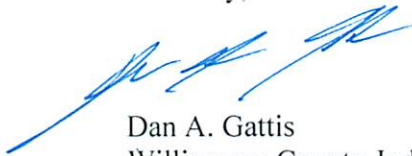
