

**FIRST AMENDMENT TO  
INTERLOCAL AGREEMENT  
FOR SCHOOL RESOURCE OFFICER PROGRAM  
BETWEEN  
ROUND ROCK ISD  
&  
WILLIAMSON COUNTY SHERIFF'S OFFICE  
(SCHOOL YEAR 2018/2019)**

This First Amendment to that certain Interlocal Agreement for School Resource Officer Program Between Round Rock ISD & Williamson County Sheriff's Office, hereinafter "First Amendment", is entered into effective as of the date of the last party's execution hereof, between the Round Rock Independent School District (hereinafter, "District"), Williamson County, Texas (hereinafter, "County"), and the Williamson County Sheriff's Office (hereinafter, "Sheriff's Office").

**RECITALS**

**WHEREAS**, District, County and Sheriff's Office executed that certain agreement entitled Interlocal Agreement for School Resource Officer Program Between Round Rock ISD & Williamson County Sheriff's Office (hereinafter, "Agreement"), which became effective on or about August 21, 2018;

**WHEREAS**, it has become necessary to amend the Agreement in order to change the commencement date of the Agreement from October 1, 2018 to August 22, 2018;

**NOW, THEREFORE**, premises considered, District, County and Sheriff's Office agree that the Agreement is amended as follows:

**AGREEMENTS**

- A.** Paragraph 8 of the Agreement shall be replaced with the following:

**Term & Termination: The term of this Agreement shall begin on the August 22, 2018 and shall terminate on September 30, 2019.** Notwithstanding any other provision of this Agreement, either party may cancel this Agreement, without cause, upon 30 days written notice or reasonable advance written notice to the other party.

- B.** Each party represents and warrants that it has due power and lawful authority to execute and deliver this First Amendment and to perform its obligations under the Agreement; and, furthermore, the Agreement and this First Amendment are the valid, binding and enforceable obligations of such party.
- C.** All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.
