### ORDER WITH RESPECT TO WASTE MANAGEMENT, INC. PROJECT

WHEREAS, WASTE MANAGEMENT, INC. and its subsidiaries or affiliates (collectively, the "Company") own and operate various solid waste disposal facilities throughout the state of Texas (collectively, the "Facilities"); and

WHEREAS, the Company has requested that Mission Economic Development Corporation (the "Issuer") issue one or more series of revenue bonds (collectively, the "Bonds"), and loan the proceeds thereof to the Company for the purpose of financing certain improvements to the Facilities (the "Project"), including to the Williamson County Landfill located at 600 Landfill Road, Hutto, Texas 78634 (the "Local Portion of the Project"); and

WHEREAS, in order that the Local Portion of the Project may be financed with the proceeds of the Bonds, the Commissioners Court (the "Commissioners Court") of Williamson County, Texas (the "County") must request that the Issuer exercise its powers within the County for the purpose of issuing such Bonds to finance the Local Portion of the Project, such request being intended to satisfy the requirements of Section 501.159 of the Texas Development Corporation Act, Texas Local Government Code, Chapter 501, as amended (the "Act"); and

WHEREAS, the Commissioners Court desires hereby to make such request of the Issuer and to take other actions to enable the Issuer to issue the Bonds and the Company to use the proceeds thereof to finance the Local Portion of the Project; and

WHEREAS, approval of the Commissioners Court as the "applicable elected representative" is also required in connection with the issuance of the Bonds as tax-exempt bonds, in order to satisfy the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code") and the Commissioners Court desires hereby to give such approval.

NOW, THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF WILLIAMSON COUNTY, TEXAS:

Section 1. <u>Third Party Financing</u>. In order that the Local Portion of the Project may be financed as a part of the entire Project through the Issuer's issuance of the bonds, the Issuer is hereby requested to exercise its powers within the County for the purpose of issuing such Bonds in one or more series to finance the Local Portion of the Project over the next thirty-six months (the "Plan of Finance"). This request is intended to satisfy the requirements of Section 501.159 of the Act.

Section 2. Public Hearing and Approval for Federal Tax Purposes. In order to comply with Section 147(f) of the Code, a public hearing has been held by or on behalf of the County, in which hearing members of the public were permitted to express their views with respect to the Plan of Finance, the issuance of the Bonds, and the financing of the Project with the proceeds thereof. Notice of such hearing was published no less than 14 days prior to such hearing in a newspaper of general circulation in the County, and an affidavit of the publication of such notice and a copy of such notice are each attached to Exhibit A hereto. Based solely upon the results of such hearing (as shown in the certificate of public hearing officer attached hereto as Exhibit A), and solely for purposes of complying with Section 147(f) of the Code, the Plan of Finance, including the issuance of the Bonds and the financing of the Project with the proceeds thereof (as described in Exhibit A), including the Local Portion of the Project, are hereby

approved. If requested by bond counsel for the Bonds, the County Judge is hereby authorized and directed to execute a certificate certifying approval of the Plan of Finance, the Bonds and the Project to be financed with the proceeds thereof, including the Local Portion of the Project.

SECTION 3. <u>DISCLAIMER OF LIABILITY</u>. THE COUNTY, THE COMMISSIONERS COURT, THE COUNTY JUDGE AND ALL OTHER COUNTY OFFICIALS MAKE NO REPRESENTATION OR WARRANTY OF ANY KIND WHATSOEVER WITH RESPECT TO THE PROJECT OR THE ISSUANCE, CREDITWORTHINESS OR REPAYMENT OF THE BONDS TO BE ISSUED BY THE ISSUER WITH RESPECT TO THE PROJECT. UNDER NO CIRCUMSTANCES SHALL THE COUNTY HAVE ANY LIABILITY, FINANCIAL OBLIGATION OR RESPONSIBILITY OF ANY KIND WITH RESPECT TO THE PAYMENT OF BONDS ISSUED FOR THE PROJECT OR FOR THE CONSTRUCTION, MAINTENANCE, OPERATION OR ANY OTHER ASPECT OF THE PROJECT.
