SUPPLEMENTAL AGREEMENT NO. 3 TO AGREEMENT FOR ARCHITECTURAL AND ENGINEERING SERVICES

WILLIAMSON COUNTY SHERIFF'S OFFICE TRAINING CENTER PROJECT ("Project")

This Supplemental Agreement No. 3 to Agreement for Architectural and Engineering Services ("Supplemental Agreement No. 3") is by and between Brinkley Sargent Wiginton Architects, Inc. (the "A/E") and Williamson County, Texas, a political subdivision of the State of Texas, (the "County").

RECITALS

WHEREAS, the County and the A/E previously executed an Agreement for Architectural and Engineering Services (the "Agreement"), in November of 2015, wherein A/E agreed to perform certain professional architectural and engineering services in connection with the Williamson County Sheriff's Office Training Center Project ("Project");

WHEREAS, following execution of the Agreement the parties executed a Supplemental Nos. 1 & 2 to the Agreement for purposes of adding additional services;

WHEREAS, due to moving the Project's main building and adding an additional support building, various professional architectural and engineering services that were not included in the original Basic Services of the Agreement would be required;

WHEREAS, Section III of the Agreement requires the parties to execute a contract modification for the performance of Additional Services not specifically described as Basic Services in the Agreement;

WHEREAS, this Supplemental Agreement No. 3 provides a description of the scope of Additional Services that are necessary, as well as the Additional Services compensation for A/E's professional services; and

WHEREAS, it has become necessary to supplement, modify and amend the Agreement in accordance with the Agreement.

AGREEMENT

NOW, **THEREFORE**, premises considered, the County and the A/E agree that the Agreement is supplemented, amended and modified as follows:

I. Scope of Additional Services

A/E hereby agrees to provide the Additional Services set forth in the attached Exhibit "A", which incorporated herein by reference.

II. Additional Services Compensation

The compensation for the Additional Services that are set out in Exhibit "A" shall be in the amount of \$29,887.50.

III. Terms of Agreement Control and Extent of Supplemental Agreement No. 3

All Additional Services described herein will be performed in accordance with the terms and conditions of the Agreement. All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the County and the A/E have executed this Supplemental Agreement No. 3, in duplicate, to be effective as of the date of the last party's execution below.

Brinkley Sargent Wiginton Architects (BSW) Additional Services

Support Building (2,020 s.f.):

An additional Support Building was requested by the County to accommodate the diving team, bicycle patrol, SWAT vehicle(s), and other vehicles used by the Sheriff's Department. This Support Building was not in the original scope of work. Services included: design and development of Support Building, Owner coordination, and consultant coordination. Work also includes expanding the footprint during design due to the County's purchase of a Bearcat vehicle for SWAT.

New CMU Wall at Firing Range:

The existing CMU wall at the adjacent firing range is collapsing. BSW oversaw the discussions and consultant coordination regarding this scope of work.

Halff Engineering/Landscape Additional Services

Support Building:

An additional Support Building was requested by the County to accommodate the diving team, bicycle patrol, SWAT vehicles(s), and other vehicles used by the Sheriff's Department. This Support Building was not in the original scope of work. Services include: additional grading at Support Building area, additional impervious calculations, and re-grading at Support Building when footprint was modified during design (Support Building needed to expand when the County purchased their Bearcat vehicle).

Sump Pump System:

A sump pump system needed to be specified and designed due to the crawl space elevation being lower than the public way tie in elevation. This was not known at the time of determining scopes of work.



Plan revision for moving of SOTC main building, moving of support building, sizing and specifying a sump pump and associated wet well, and design of additional enhanced landscaping elements: Moving of buildings will require additional site grading with new configuration to accommodate stormwater runoff. Halff Associates will prepare plan revisions as outlined in the table below for the Sheriff's Office Training Center site development drawings.
