On behalf of Williamson County, I respectfully request consideration to receive a Community-specific Integrated Emergency Management Course (IEMC). We have determined that Williamson County meets the criteria for application and selection for this course conducted by FEMA's Emergency Management Institute (EMI). We understand that approval for an IEMC will require a major commitment from our county. As such, I believe our county is an ideal candidate and would benefit significantly from participation in this course to exercise our emergency operations center (EOC) SOPs and our emergency operations plans.

As explained in detail in this application package, Williamson County is located in the Austin-Round Rock Metropolitan Statistical Area and has a population of approximately 545,412 permanent residents with a peak business-day population of 500,000. Within the last ten years, Williamson County has consecutively been in the top 10% of the fastest growing counties within the nation.

We request an IEMC program that will help to prepare us for a Community-Specific IEMC relating to flood response and recovery. The attached documents provide detailed information concerning our current emergency management program and our disaster history.

If this application is selected for a community specific IEMC in FY2020, Williamson County agrees to follow and apply all relevant evaluation and assessment guidance (EEG, Lesson Learned,) and to follow the Homeland Security Exercise and Evaluation Program (HSEEP) After Action Report (AAR) format. Williamson County is responsible for the development of a formal After-Action Report and Improvement Plan. A copy of the After-Action Report will be provided by the community to the FEMA/EMI/EM Branch within eight months of the course completion.

We request your endorsement of this nomination package to be forwarded to the FEMA Region (6) Administrator along with our application package.

Does the course / exercise support your jurisdictional Threats and Hazards Identification and Risk Analysis? Yes, we are requesting that the exercise relating to flooding which is the number one natural hazard for Williamson County. The Office of Emergency Management has recently completed a County Flood Protection Plan that clearly details the specific flood risk within Williamson County.

Is the community scheduled to participate in a National Level Exercise within the next two years? No, Williamson County is not currently scheduled to participate in this level of exercise.

Explanation of why the community desires a CS-IEMC.

Williamson County is uniquely located in Central Texas between the state capital and Ft. Hood military installation. The county continues to experience high rates of population and business growth, creating new challenges for emergency management, public safety, and other county departments. In the past 20 years, the county has transitioned from a mostly rural agriculture atmosphere to a thriving business centric county. This growth has placed more residents and businesses at risk for a number of hazards, with flash flooding being number one natural hazard.

Williamson County sits in "Flash Flood Alley" and has experienced an ever-increasing number of devastating floods, both declared and undeclared as presidential disasters. Through the recent completion of a comprehensive County Flood Protection Plan, the risk has now become more evident as the analysis shown areas of the county to be at extreme risk levels. While mitigation is the key to reduction, the county will be faced with increasing complexed flood response for the foreseeable future.
