This Change Order Estimate includes the following modifications to the scopes of work originally contracted for the subject project between **Ritter – Botkin Prime Construction Company Inc.** (Contractor) **Williamson County** (Owner):

SCOPE:

Furnish and install all materials, tools, and labor required for the following scopes of work

1. ASI No 1. - OSSF, COMM

\$150,906.00

Furnish and install added power requirements for septic systems and additional electrical and communication conduit per ASI 01 dated 3/20/19.

Inclusions:

- Stub up electrical conduit in slab at Maintenance Building, Day Use Pavilion, RV Bath House, and Headquarters for septic and communication requirements. Run conduit out 5ft from edge of slab and cap.
- Build equipment racks at each septic location. Provide and install NEMA 3 disconnects at each location. Pull wire from panels to septic system disconnects and make necessary connections.
- Cut, back-fill and compact 3,497 additional LF of Conduit for OSSF
- Supply and install an additional (6) OSSF J-Boxes (12" x 12" Composite w/ Elec Cover)
- Cut, back-fill and compact 1,130 additional LF of Conduit for COMM
- Supply and install an additional (8) COMM pull boxes
 - Underground Enclosure Assembly, Blank
 - 33-7/8"L x 22 1/4"W x 15"H nominal dimensions
 - Include (4) concrete curbs

Exclusions:

- Septic or communications equipment/materials not specified above
