THIS ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County" or "Client"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **American Institute of Toxicology, Inc.** (hereinafter "AIT"), an Indiana corporation. County agrees to engage AIT as an independent contractor, to assist in providing certain operational services pursuant to the following terms, conditions, and restrictions:

**I.**

**Incorporated Documents:** This Agreement constitutes the entire Agreement between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Agreement include the following:

- A. Original Agreement signed by AIT on April 13, 2020, including attached Exhibit "A"; and
- B. This Williamson County Addendum.

**II.**

**Exhibit "A" Fee:** This amendment will change the fee amount in Exhibit "A" to reflect that Client shall pay AIT a fee of **\$100.00** per specimen for Infectious Disease ("ID") Testing for the COVID 19 pathogen as medically necessary, offered by AIT and ordered by an authorized ordering provider.

### III.

In all other respects, the Agreement and Exhibit "A" are both reaffirmed.
