- II. The Work Authorization shall terminate on <u>September 30, 2020</u>. The Services to be Provided by the Engineer shall be fully completed on or before said date unless extended by an additional Supplemental Work Authorization. The revised Work Schedule is attached hereto as Attachment "C" (must be attached).
- III. The maximum amount payable for services under the Work Authorization is hereby increased from \$901,669.50 to \$932,335.50. The revised Fee Schedule is attached hereto as Attachment "D" (must be attached).

Except as otherwise amended by prior or future Supplemental Work Authorizations, all other terms of the Work Authorization are unchanged and will remain in full force and effect.

This Supplemental Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.

Objective

The objective of this Hairy Man Road/Brushy Creek Road work authorization is to prepare the Plans, Specifications and Estimates (PS&E) package and associated environmental and geotechnical studies for the Brushy Creek Road/Hairy Man Road Shoulder and Turn Lane Improvements.

Project Description

The project limits are Hairy Man Road/Brushy Creek Road from the Brushy Bend Drive low water crossing to Sam Bass Road. Hairy Man Road/Brushy Creek Road is currently a 2-lane undivided facility with narrow to no shoulders within the project limits.
