COUNTY ADDENDUM FOR
MASTER SERVICES AGREEMENT WITH
STANLEY Convergent Security Solutions, Inc.**

THIS ADDENDUM to the existing Master Services Agreement (the "Agreement") by and between STANLEY Convergent Security Solutions, Inc. is made and entered into by and between **Williamson County, Texas** (hereinafter "Customer"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **STANLEY Convergent Security Solutions, Inc.** (hereinafter "SCSS"). Customer agrees to engage SCSS as an independent contractor, to assist in providing certain operational goods and services pursuant to the following additional terms, conditions, and restrictions:

I.

Not-to-Exceed Amount: The not-to-exceed amount for any 12-month term under this Agreement shall be **\$400,000.00**, unless revised by the Williamson County Commissioners Court through a written amendment signed by both parties.

II.

In all other respects, the Agreement is reaffirmed.
