SCOPE CHANGE REQUEST

Additional Services/Modified Services:

Facilities that this Scope Change Request applies to:

Williamson County Adult Detention Center, 306 West 4th Street, Georgetown, TX 78626. Material adverse change in operations in the contract. This clause expressly refers to a drop in population.

Description of additional or modified services:

The terms of this Scope Change Request as set forth herein, amend the Jail Inmate Food Service Contract for the Williamson County Jail, which was entered into by the County of Williamson, Texas (“**County**”) and Aramark Correctional Services, LLC (“**Aramark**”) for the management of food service operation at the Facility stated above, and effective on August 1, 2016 (as amended, the “**Agreement**”). Pursuant to Section 38 of the Agreement, which permits modification of the Agreement, including an adjustment to Aramark’s price per meal, to offset the impact of a decrease in the Facility’s inmate population, the County and Aramark desire to amend the Agreement to revise and update the meal pricing scale to account for changes in the population at the Facility, as more particularly described herein.


Description of timing/effective date of additional or modified services:

The adjustments to Aramark's price per meal, as more particularly described herein, are effective as of August 1, 2020

Description of financial impact/billing process for additional or modified services:

The parties agree that, due to the drop in adult inmate population, the applicable price per meal for each adult inmate in the Facility charged to the County by Aramark shall be changed as set forth below, and shall supersede in all respects the prior price per meal for adult inmates in any other prior agreements between the parties.

In the event that the population drops below 100, the County and Aramark shall promptly negotiate in good faith to determine an equitable adjustment in the inmate meal rates to compensate Aramark for the effect of such decline.
