Re: FY 21 CSCD Memorandum of Understanding -Pre-Trial Services

Date: August 11, 2020

This MOU between Williamson County and Williamson County Community Supervision and Corrections Department (CSCD) is to continue providing community-based supervision services to felony offenders released from jail and ordered to be monitored on Pretrial Bond Supervision. The MOU provides for four staff members who work with Pre-Trial cases, GPS tracking services, and for the cost of drug testing. Thus far, in FY20 there were 497 felony participants served in Pretrial Services which provides a significant cost savings to the County and continues to provide a high level of public safety while pending disposition of the felony cases.

In FY21 responsibility for the Pre-Trial Services Unit will transition away from the CSCD and will be operated by Williamson County Pre-Trial Court Services Department. It is written in the FY21 MOU, for payments to be monthly until full transition of the unit is completed.


Memorandum of Understanding


The Williamson County Commissioners Court agrees to fund the Pre-Trial Release Unit for the Williamson County CSCD for a portion of the fiscal year 2021 as set forth in the below, and in an amount not to exceed \$261,559.00.

Williamson County CSCD agrees to maintain the supervised release of approved defendants in felony cases from the Williamson County Jail.

Williamson County CSCD and the Williamson County Commissioners Court jointly agree to transition these responsibilities to Williamson County Pretrial Services during the course of this Fiscal Year, at a date to be agreed-upon by the parties, and no later than February 28, 2021.

Williamson County shall pay \$21,796.58 on a monthly basis to the Williamson County CSCD, to be deposited in fund #591, in the months where Williamson County CSCD manages the program set forth above.
