SCOPE:

This is a Time and Materials Proposal for the Texas Materials Project:

Daryl Flood Logistics Scope of Work

From: Texas Materials, 3099 IH 35 N Round Rock TX,

To Destination: 8165 Chandler Rd. Hutto TX.

PHASE I:

Delivery of moving materiel for personnel and relocation (boxes, labels). 3-15-20.

Office/Garage: Daryl Flood (DFL) crews will arrive at 8am 3-23-20 daily Monday thru Tuesday 3-25-20, crews will unload equipment and pack and sort boxes and furniture for loading onto trucks. DFL crew will load trucks, once one truck is loaded that truck will depart for the Destination. DFL Destination crew will depart for Destination. The Origin Crew will stay and load and prepare trucks for departure for the Destination. This process (Round Robin) will continue until the Office and Garage are completely relocated. All items will be placed at the Destination with the direction of Texas Materials assistance.

Phase 1 (a) DFL will Rig, Haul, and unload: 3 Sealer Tanks approximately 5000lbs each, 1 40ft tall, Sand Hopper, 1 structural frame under hopper, 2-2000-gallon Bulk fuel tanks, and 30 concrete blocks weighing approximately 1000lbs each. Date TBD.

The catwalks will be cut away from the tanks and hopper and hauled to the Destination. Installation will be completed at Destination with concrete piers installed.

All utilities and piping to be disconnected by owner prior to riggers arrival

All Tanks and Hopper to be emptied by others prior to riggers arrival. **(Haz-mat paperwork to be filled out and copies returned to DFL prior to hauling).**

Scope Disconnect and reconnect of 2 - 2000-gallon fuel tanks:

Obtain Hutto fire permit for fuel system.

Dismantle Round Rock Fuel System

Pump all residual liquids and dispose of as per TCEQ

Pressure wash tanks for safe transportation using a LEL meter

Remove decals for transportation

Install piping and reuse all equipment, with exception to unleaded dispenser

Install piping and reuse all equipment, with exception too unleaded dispenser

Install 1 new Wayne S1 style remote fuel dispensers, for unleaded to meet newest code requirements

Install new electrical from owner's sub J-Box at containment (stub must be rigid to the ground and wire pulled to J-box)

Obtain COHFD inspections.

All rigging work will be done during normal business hours M-F 7am thru 3:30pm

Phase 2:

Yard: DFL will arrive 8am 3-25-20, DFL crews will arrive unload equipment (pallets, banding materiel, hydraulic dollies, ((forklifts Origin and Destination)) Flatbed trailers and bobtails. DFL will begin palletizing all yard equipment/items, this will be done in sections. 1 thru 10. Once sections 1 thru 2 is complete DFL crews will proceed to load Flat bed trailers and strap down loaded pallets for transport. Trailers will then depart for the Destination. Once at the destination DFL Crews will unload flatbeds and place equipment/items at Old Castle/wheeler's direction. This will continue as a (Round Robin) until Project is complete.

Phase 2 (a) DFL crews will relocate 3 Conex's two 20' and one 40' to the Destination and placed at the direction of OCW. The equipment and tools inside of these Conex's will need to be packed.

Phase 3: DFL Crews will relocate **Hazardous Materials:**

1. 5 fifty-five-gallon drums of solvent or solvent containing material
2. 3 fifty-five-gallon drums of aerosol paint material
3. 1800 pounds of paint (latex/solvent) 25 pallets.

This project is slated to begin 3-23-20 and end July 2020.

Any changes to this proposal will need a signed change order from OCW and DFL.
