

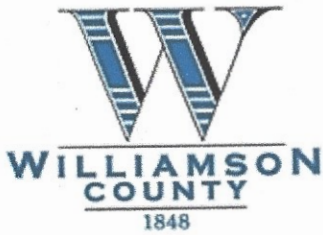

As applicable and as indicated in the Proposed Move Plan:

- If Daryl Flood's pricing is a Total Guaranteed Price, then pricing is based on the information contained in this Statement of Work and Proposal, and the Total Guaranteed Price is the price Customer will pay for the Services.
- If Daryl Flood's pricing is a Total Estimated Price, then pricing is guided by the information contained in this Statement of Work and Proposal; however, Daryl Flood will charge, and Customer will pay, based on actual time and materials used in the provision of services.
- Total Estimated Price includes industry standard travel time and minimum service times and will be invoiced to Customer.
- If there is a material variation to the Inventory or Proposed Move Plan prior to Daryl Flood's commencement of Services, Customer will need to sign a new Statement of Work and Proposal.
- If there are variations to the Inventory or Proposed Move Plan after commencement of Services, Customer will need to sign a change order, which may include additional charges.
