

RELEASE OF EASEMENT

This Release of Easement is executed as of the 6th day of October, 2020 by WILLIAMSON COUNTY, TEXAS.

RECITALS:

A. WHEREAS, the Public was granted a sight line easement along County Road 180 crossing Lot 1, Block B of the Post Oak Estates, recorded in Cabinet N, Slide 174 as Document Number 9640296 of the Official Records of Williamson County, Texas ("Plat"); and

B. WHEREAS, the sight line easement on Lot 1, Block B of the Post Oak Estates was provided for line of sight from Old County Road 180 intersecting with County Road 180; and

C. WHEREAS, Old County Road 180 Right-of-Way has been abandoned by Williamson County; and

D. WHEREAS, County Road 180 south of Lot 1, Block B of the Post Oak Estates has been converted to a cul-de-sac with the completion of the New Hope Drive extension and is no longer a thru roadway; and

E. WHEREAS, the County Engineering Department has determined that the sight line easement on Lot 1, Block B is no longer needed, and will not be required in the future; and

F. WHEREAS, Owners of Lot 1, Block B of the Post Oak Estates request that the sight line easement be released in full, as depicted in Exhibit "A".

NOW, THEREFORE, the undersigned, being the duly authorized signatory for Williamson County, Texas, in consideration, the receipt and adequacy of which is hereby acknowledged, has this day, and does by these presents, RELEASE, DISCHARGE and QUITCLAIM all of the right,

title, interest and estate in and to the sight line easement located on and across Lot 1, Block B, described in Exhibit "A", which the undersigned has or may be entitled to by virtue of said easements, and does hereby declare the same fully released and discharged.

BEING 23,028 SQUARE FEET, MORE OR LESS, OVER LOT 1, BLOCK B, POST OAK ESTATES, A SUBDIVISION IN WILLIAMSON COUNTY, TEXAS, AS SHOWN UPON THE PLAT OF RECORD IN CABINET N, SLIDE 174, PLAT RECORDS OF WILLIAMSON COUNTY, TEXAS, SAID 23,028 SQUARE FOOT SIGHT LINE EASEMENT, AS SHOWN ON THE ACCOMPANYING SKETCH, BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING, AT A 1/2 INCH IRON ROD FOUND IN THE EAST RIGHT-OF-WAY OF COUNTY ROAD NO. 180 (RIGHT-OF-WAY VARIES - CABINET N, SLIDE 174) ALSO BEING THE WEST LINE OF SAID LOT 1;

THENCE, N 03°02'49" E, WITH THE COMMON LINE OF SAID LOT 1 AND SAID COUNTY ROAD NO. 180, A DISTANCE OF 83.57 FEET TO A 1/2 INCH IRON ROD SET FOR THE POINT OF CURVATURE OF A CURVE TO THE RIGHT;

THENCE, ALONG SAID CURVE TO THE RIGHT WHOSE RADIUS IS 440.00 FEET, AND CHORD BEARS N 11°20'46" E, 177.17 FEET, FOR AN ARC DISTANCE OF 178.39 FEET TO A 1/2 INCH IRON ROD FOUND FOR THE POINT OF CURVATURE OF A CURVE TO THE RIGHT;

THENCE, ALONG SAID CURVE TO THE RIGHT WHOSE RADIUS IS 435.00 FEET, AND CHORD BEARS N 38°29'26" E, 174.91 FEET, FOR AN ARC DISTANCE OF 176.11 FEET TO A CALCULATED POINT;

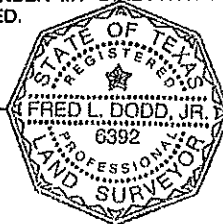
