Original Allocation: \$750,000

- Financial Assistance for Families
- PPE/Supplies
- Staffing costs
- Contract janitorial Services

Additional Request: \$406,000

- Financial Assistance for Families
- Virtual Learning Program
- Staffing for childcare
- Compliance Costs (Single Audit)



NEW REQUEST: FOOD BANKS

Background

- We've heard from 5 food banks so far
- Requested assistance ranges from \$12,000 \$62,000
- Services provided and situations vary greatly

Proposal

- \$500,000 allocation to food banks
- Maximum \$50,000 per applicant
- Must be 501(c)(3) that provides food and other services to the community
- Must be based in Williamson County (and not in City of Austin)
- Eligible Expenses
 - Increased cost of food and other distributed items (Compare Mar-Nov 19 to Mar-Nov 20)
 - Increased staffing costs (Compare Mar-Nov 19 to Mar-Nov 20)
 - PPE
 - Storage costs (allow for new refrigeration/freezer equipment up to \$5,000 per applicant)
