- B. This Williamson County Addendum.

<u>Compliance with All Laws</u>: BTCS agrees and will comply with any and all local, state or federal requirements with respect to the services rendered.

Attachment "A" Allowable Expenses: This amendment will change the allowable expenses set forth on Attachment "A" to add and cover allowed additional costs with a revised total not-to-exceed amount of one million four hundred twenty-four thousand one hundred twenty-five dollars (\$1,424,125.00).
