**COUNTY ADDENDUM FOR
INTERLOCAL AGREEMENT ON
PRIVATE PSYCHIATRIC HOSPITAL
BEDS NECESSARY DURING COVID-19
(Bluebonnet Trails Community Services)**

Important Notice: County Purchase Orders and Contracts constitute expenditures of public funds, and all vendors are hereby placed on notice that such procurement is subject to the extent authorized by Texas law, including but not limited to Tex. Const. art. XI, § 7, the Texas Government Code, the Texas Local Government Code, the Texas Transportation Code, the Texas Health & Safety Code, and Opinions of the Texas Attorney General relevant to local governmental entities.

THIS ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Bluebonnet Trails Community MHMR Center d/b/a Bluebonnet Trails Community Services** (hereinafter "BTCS"), a political subdivision of the State of Texas, acting herein by and through its governing body. The County agrees to engage BTCS as an independent contractor, to assist in providing certain operational services pursuant to the following additional terms, conditions, and restrictions:

I.

Incorporated Documents: This Agreement constitutes the entire Agreement between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Agreement include the following:

- A. Original Agreement approved by Williamson County Commissioners Court on August 4, 2020, including attachment(s); and
- B. This Williamson County Addendum.

II.

Compliance with All Laws: BTCS agrees and will comply with any and all local, state or federal requirements with respect to the services rendered.

Attachment "A" Allowable Expenses: This amendment will change the allowable expenses set forth on Attachment "A" to add and cover allowed additional costs with a revised total not-to-exceed amount of one million four hundred twenty-four thousand one hundred twenty-five dollars (\$1,424,125.00).

In all other respects, the Interlocal Agreement is reaffirmed.

Note 1: Bluebonnet Trails Community Services won competitive funding through the state paying for 5.3 private psychiatric hospital beds at a rate of \$625/bed for each day of the year. This is a combined number of privatized psychiatric hospital beds to serve children and adults in our eight county area - including Williamson County residents. Bluebonnet Trails Community Services was awarded CARES Act funding by the Williamson County Commissioners Court to serve Williamson County residents in need of this intensive level of crisis care offered through private psychiatric hospitals during the COVID-19 pandemic. The award period is designated as March 16, 2020 through December 31, 2020.

Note 2: Bluebonnet Trails Community Services was awarded CARES Act funding by the Williamson County Commissioners Court to serve Williamson County residents in need of this intensive level of crisis care offered through private psychiatric hospitals during the COVID-19 pandemic. The award period is designated as March 16, 2020 through December 31, 2020.

Note 3: Williamson County paid \$500,000 supporting Williamson County lives extending psychiatric hospitalization care for Williamson County families from March 16, 2020 through July 24, 2020.

Note 4: The projection for additional costs serving Williamson County residents from July 25, 2020 through December 31, 2020. Key for consideration is the projection of bed use during December 2020 (calculated on 12/2/2020).
