**COUNTY RENEWAL ADDENDUM FOR
MASTER SERVICES AGREEMENT
SUPPORTING OPERATIONS OF THE
WILLIAMSON COUNTY FACILITIES DEPARTMENT
(MTECH - BuyBoard Contract #558-18)**

THIS ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Mechanical Technical Services, Inc.** (hereinafter "MTECH"). MTECH is engaged as an independent contractor, to assist in providing certain operational services pursuant to the following terms, conditions, and restrictions:

I.

Incorporated Documents: This Agreement constitutes the entire Agreement between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Agreement include the following:

- A. Original Master Services Agreement approved by Williamson County Commissioners Court on December 17, 2019, including attached exhibits; and
- B. BuyBoard Contract #558-18, including any addenda; and
- C. This Williamson County Renewal Addendum.

II.

Term: This amendment will renew this Agreement for an additional one (1) year term and continue until December 31, 2021. The parties may renew at the end of 2021 pursuant to Section 10.1 of the original Master Services Agreement.

III.

In all other respects, the Agreement is reaffirmed.


