

# A Need for Capacity: District and County Courts at Law Request for Additional Courts

# Top Line Conclusions

- Tx. Office of Court Administration DATA supports the need for additional court capacity in Williamson County.
- Williamson County's growth and an increased utilization (overall) of the Justice System DRIVES the need.
- While data supports the need for more, the Judges respectfully ask the Commissioners to support a request for one (1) District Court and one (1) County Court at Law to address the current workload.
- The Judges have carefully developed this request in a way that will minimize the impact on other departments and avoid the need to add prosecutorial resources.

Dear Judge Gravell and County Commissioners,

The Judges of the District Courts and County Courts at Law serving Williamson County request your support in seeking legislation to add one District Court and one County Court at Law in our county. Attached is a proposed resolution for your consideration.

As you know, Williamson County has enjoyed significant population growth in the fifteen years since the last new courts were created. This will only continue in the years to come, and results in a thriving community that we are all privileged to serve. Our role in the face of such positive growth is to provide the judicial services that the public relies on.

In our report explaining this request, we provide data from the Texas Office of Court Administration that reflect a clear need for additional judicial capacity. Providing that capacity is critical to our ability to ensure efficient access to justice and effectively manage the increasing number of cases brought to Williamson County courts. After careful consideration of several options, we have identified a solution that will best allow us to balance our responsibilities to the public with our commitment to fiscal responsibility. We ask you to support our request to add a District Court and a County Court at Law, with dockets assigned such that there will be no more than the current number of three (3) District Courts and three (3) County Courts at Law hearing criminal cases. It will allow the public timely access to the courts while allowing judges to continue thoughtfully considering the cases brought before them. Importantly, we will be able to do both in a way that is conscientious of the County's fiscal responsibilities.

This request is presented to you jointly by the undersigned Judges of the District Courts and County Courts at Law and we agree to enact any local rules or docket assignment orders which may be necessary to effect this plan and facilitate the establishment of the requested courts.

We are grateful for your consideration and all that you do to support us in our work.
