#### **AGREEMENT**

#### **Additional Services/Modified Services:**

#### Facilities that this Interim Amendment applies to:

Williamson County Jail

#### Description of additional or modified services:

The terms of this Interim Amendment ("Amendment") as set forth herein, amend that certain Operating Agreement – Food Service, which was entered into by the County of Williamson, Texas ("County") and Aramark Correctional Services, LLC ("Aramark") on or about August 1, 2016 (as amended, the "Agreement") for the management of the food service operation at the Williamson County Jail facilities. County and Aramark agree that due to the impacts of the COVID-19 pandemic at such facilities, to offset the impact of a lack of availability of inmate labor, the County and Aramark desire to amend the Agreement on an interim basis to: adjust the menu served, convert to a sack lunch format, and provide for use of certain disposable supplies, together with a corresponding adjustment to the price per meal rates, as more particularly described below.

#### Description of timing/effective date of additional or modified services:

Aramark shall immediately (as of January 26, 2021) implement the menu adjustments described above in the food service operations at the facilities, and such menu, and the corresponding adjustments to Aramark's price per meal, as more particularly described below, shall continue until the parties mutually agree in writing that the availability of inmate labor is sufficient to resume normal menu meal service, and such service in facts resumes as mutually agreed by the parties. The parties anticipate at least a 14-day period of such adjusted operations and pricing.



#### Description of financial impact/billing process for additional or modified services:

The parties agree that for so long as this Amendment is in effect, the applicable price per meal for meal service pursuant to the Agreement shall be changed as set forth below (a new sliding scale with an \$0.58 per meal price increase, corresponding to increases of \$0.567 for the menu adjustments and \$0.013 for disposables), and shall supersede in all respects the prior price per meal in any other prior agreements (or amendments the same) between the parties, including the Agreement.

Until the end of the current fiscal year (September 30, 2021), the parties reserve the right to implement this temporary food program at the pricing levels stated herein on an as-needed basis provided there is sufficient funding and an approved purchase order for same issued by the County, and which will be paid pursuant to the standard invoicing and payment terms of this Agreement.
