COUNTY ADDENDUM FOR  
SOCIAL SERVICE FUNDING AGREEMENT  
WITH ROUND ROCK AREA SERVING CENTER**

**Important Notice:** County Purchase Orders and Contracts constitute expenditures of public funds, and all vendors are hereby placed on notice that such procurement is subject to the extent authorized by Texas law, including but not limited to Tex. Const. art. XI, § 7, the Texas Government Code, the Texas Local Government Code, the Texas Transportation Code, the Texas Health & Safety Code, and Opinions of the Texas Attorney General relevant to local governmental entities.

THIS SECOND ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Round Rock Area Serving Center** (hereinafter "Agency"), a non-profit corporation, located at 1099 East Main, Round Rock, Texas 78664 to engage Agency as an independent contractor, to assist in providing certain operational services pursuant to the following additional terms, conditions, and restrictions:

**I.**

**Incorporated Documents:** This Agreement constitutes the entire Agreement between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Agreement include the following:

- A. Original Agreement signed by Agency on July 20, 2020, including attached Exhibit(s);
- B. Williamson County Addendum for Funding, approved on November 17, 2020; and
- C. This Williamson County Second Addendum for Funding.

**II.**

**Term:** The term of this Agreement is from the effective date to June 30, 2021.

III.


**Exhibit "A" Allowable Expenses:** This amendment will change the allowable expenses set forth on Exhibit "A" to add and cover the reasonable costs of temporary staff to process the applications and the pro rata share of the Agency's single audit cost associated with managing these funds. The not-to-exceed amount for these additional costs are seventy thousand dollars (\$70,000.00) for a grand total and not-to-exceed amount under this Agreement of one-hundred-thirty-eight thousand dollars (\$138,000.00).

IV.

In all other respects, the Agreement is reaffirmed.
