To Whom It May Concern:

As you are aware, Williamson County is currently receiving services from your company for the Tax Assessor Collector's Office under Request for Proposals 2009 (Customer Flow Queuing /Management System) and subsequent sole source findings to exempt from bidding. The Williamson County Commissioners Court, as the legislative body for the county, has approved a termination of these services at the end of the current fiscal year. As a result, the services received from your company will terminate effective at the end of business (5:00 p.m. Central Time) on September 30, 2021.
