Important Notice: County Purchase Orders and Contracts constitute expenditures of public funds, and all vendors are hereby placed on notice that such procurement is subject to the extent authorized by Texas law, including but not limited to Tex. Const. art. XI, § 7, the Texas Government Code, the Texas Local Government Code, the Texas Transportation Code, the Texas Health & Safety Code, and Opinions of the Texas Attorney General relevant to local governmental entities.

THIS ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter “County”), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Aramark Correctional Services, LLC** (hereinafter "Service Provider"), 1101 Market Street, Philadelphia, PA 19107. The County and Service Provider agree to the following additional terms to the Contract between the parties:

I.

Incorporated Documents: This Contract constitutes the entire Contract between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Contract include the following:

- A. Original Jail Inmate Food Services Contract for Williamson County Jail (August 1, 2016) (initial term through July 31, 2021);
- B. Amendment No. 1 (Price Changes, signed December 11, 2018);
- C. Amendment No. 2 (on or about August 1, 2019) (term renewal through July 31, 2020);
- D. Amendment No. 3 (Price Changes, signed July 21, 2020);
- E. Amendment No. 4 (Extension to July 31, 2021, signed July 21, 2020);
- F. Amendment No. 5 (Interim Amendment Due to Coronavirus, signed February 23, 2021); and

G. This Amendment No. 6 (Extension to October 31, 2021).

II.

Term Extension: Unless the Contract is terminated earlier based on termination-for-convenience, this amendment will extend the term of this Contract until **October 31, 2021** in order to allow sufficient time for The County to evaluate a new solicitation in this category of services.

III.

Service Provider's address in Section 39(e) is revised to: 2400 Market Street, Philadelphia, PA 19103.

IV.

In all other respects, the Interlocal Contract is reaffirmed.
