Williamson County, Texas (Effective September 15, 2021)***

To Whom It May Concern:

As you are aware, Williamson County, Texas is currently in a contract with your company as referenced above. The Williamson County Commissioners Court has approved changes in this category of services, including the present contract. Pursuant to the terms and conditions set forth in the contract, Appendix A authorizes termination for convenience and states in relevant part:

This Agreement may be terminated, with or without cause, by either party by providing written notice to the other party at least ninety (90) days prior to the intended date of termination.

As you are also aware, Appendix A also states in pertinent part that the Williamson County terms are:

... an integral part of the Agreement and must be regarded as an essential part of the Agreement. In the event of conflict, the following ranking applies:

- 1) **Williamson County terms;**
- 2) **Cover Page;**
- 3) **GT;**
- 4) **SLA.**

Therefore, the purpose of this letter is to give you official notice that Williamson County elects to terminate the agreement between the parties, and such termination will be effective at the end of business on September 15, 2021.
