THIS ADDENDUM TO THE SOCIAL SERVICE FUNDING AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and the **Williamson County Crisis Center d/b/a Hope Alliance** (hereinafter the "Agency"). County agrees to continue engaging Agency as an independent contractor, to assist in providing certain operational services pursuant to the following terms, conditions, and restrictions:

**Incorporated Documents:** This Agreement constitutes the entire Agreement between the parties and may not be modified or amended other than by a written instrument executed by both parties. Documents expressly incorporated (as if copied in full) into this Agreement include the following:

- A. Original Social Service Funding Agreement; and
- B. This Williamson County Addendum.

**Shelter services** include nights of safety, transportation, crisis intervention, intake, hospital accompaniment, court accompaniment, legal assistance, peer support, adult counseling, child counseling, family counseling, support groups, and therapeutic group.

Total Units of Service for both service types not to exceed 36,372.

Average cost per unit of service ranges from \$22.68 to \$38.89.

Total funding not to exceed \$1,000,000.00.
