RESOLUTION

WHEREAS, an analysis of the 2020 decennial federal census disclosed that existing County Commissioner precincts in Williamson County, Texas are substantially unequal in population; and

WHEREAS, the Commissioners Court of Williamson County has undertaken to redraw the County Commissioner precinct boundaries to equalize the population of the respective districts in compliance with applicable requirements of state and federal law; and

WHEREAS, the Commissioners Court of Williamson County has undertaken to redraw the Justice of the Peace and Constable precinct boundaries to take into account the proposed changes to the Commissioner precincts; and

WHEREAS, through public comments and meetings, the Commissioners Court of Williamson County has received and considered comments and proposed plans regarding the appropriate configuration of those Commissioner, Constable and Justice of the Peace precinct boundaries to balance the population of the respective precincts.

NOW THEREFORE BE IT RESOLVED, pursuant to the United States Constitution, the Texas Constitution, applicable Texas Statutes, as amended, Williamson County, Texas shall be divided into four (4) County Commissioner, Constable and Justice of the Peace precincts as depicted in Exhibit "A" to this Resolution, which is a map denoted "Exhibit "A"" accurately depicting the boundaries and territories of the respective County Commissioner, Constable, and Justice of the Peace precincts as redrawn, and which map is incorporated by reference into and made a part of this Resolution; and Exhibit "B" to this Resolution, which is a description of the metes and bounds of each respective Commissioner, Constable and Justice of the Peace precinct which is incorporated by reference into and made a part of this Resolution; and; that such Williamson County Commissioner, Constable and Justice of the Peace precincts shall be effective for office terms beginning January 1, 2023 and later, for elections held in 2022 for those offices; and to the extent there is a conflict between Exhibit "A" and Exhibit "B", Exhibit "A" shall govern.

PASSED, APPROVED, ADOPTED and RESOLVED as of this this 12th day of November 2021.


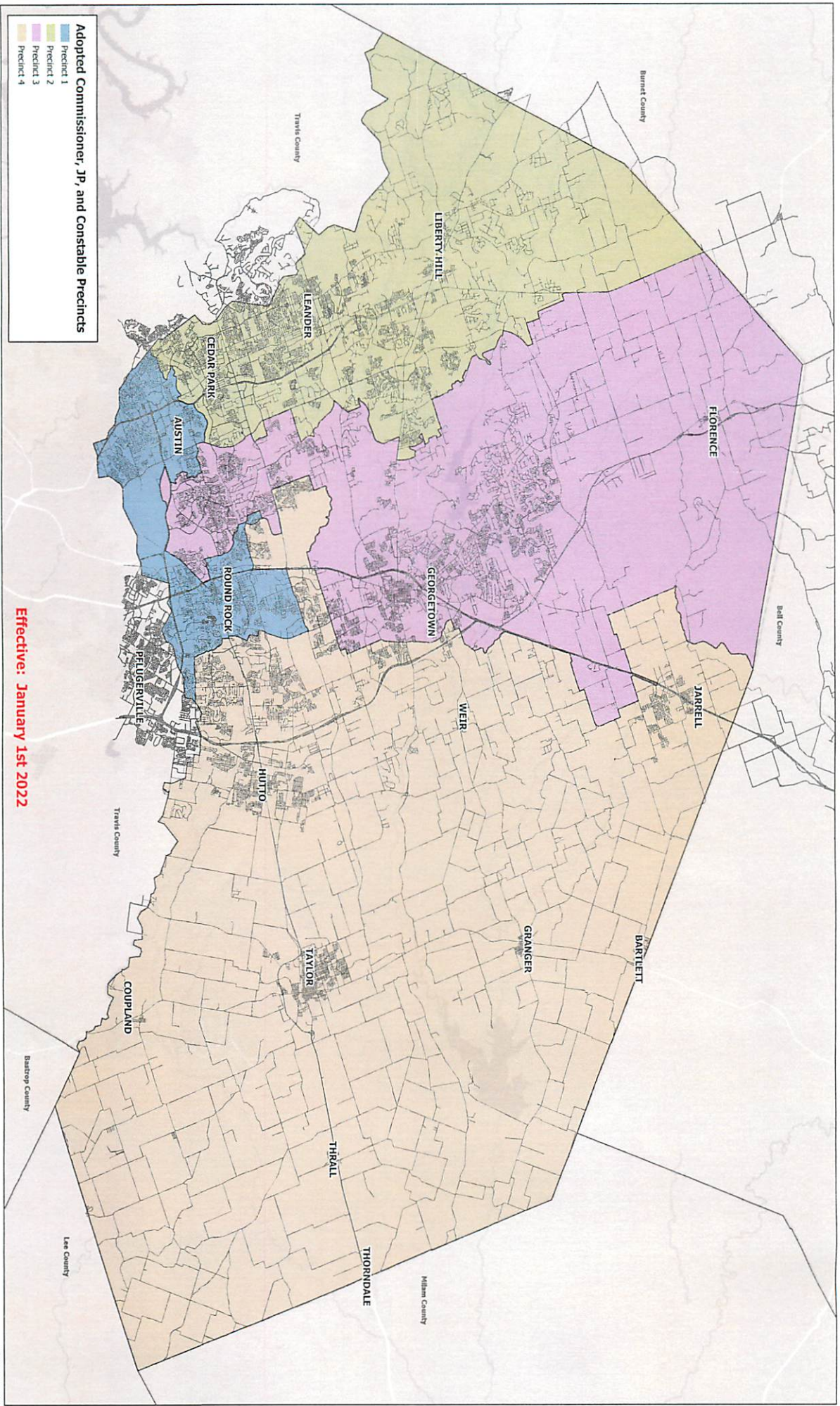
