

# **Amendment 1 to Capital Area Council of Governments Interlocal Agreement for 9-1-1 Geographic Information System Database Management**

The Capital Area Council of Governments ("CAPCOG") entered into an Interlocal Agreement (ILA) with Williamson County (PUBLIC AGENCY) on November 17, 2021. This amendment is authorized under Section 13.3 of the original ILA, which authorizes amendments by mutual agreement. The purpose of this amendment is to correct the contract price and invoice amounts to match the amount approved by the Capital Area Emergency Communications District (CAECD) Board of Managers on October 13, 2021, for this contract. The amount in existing executed agreement was incorrect, in that it reflected the total amount budgeted for PUBLIC AGENCY for Fiscal Year 2022, rather than the nine-month period covered by this contract. Invoice dates for some periods also incorrectly listed 2021 dates rather than 2022 dates. Finally, the amendment also updates CAPCOG's project representative.

## **AMENDMENT**

### **Section 5: Contract Price and Payment Terms is amended as follows:**

5.1: For work performed under this agreement, CAPCOG agrees to compensate PUBLIC AGENCY an amount not to exceed ~~\$419,672.60~~ \$314,754.45.

5.2: PUBLIC AGENCY agrees to invoice CAPCOG as follows for work performed during these quarters:

January 1, 2022 – March 31, 2022: ~~\$139,890.87~~ \$104,918.15, invoice due by close of business, ~~Wednesday~~ Thursday, April 7, 2022;

April 1, 2022 – June 30, 2022: ~~\$139,890.87~~ \$104,918.15, invoice due by close of business, ~~Thursday~~ Friday, July 8, 2022; and

July 1, 2022 – September 30, 2022: ~~\$139,890.86~~ \$104,918.15, invoice due by close of business, ~~Thursday~~ Friday, October 7, 2022.

Timely submission of invoices will be considered in CAPCOG's evaluation of PUBLIC AGENCY's performance of this ILA, and CAPCOG reserves the right to reject any invoice submitted more than 90 days after the end of each quarter.

### **Section 12.5 is amended as follows:**

12.5: ~~Susan Cooper, CAPCOG GIS Program Manager, Nik Pullias, CAPCOG GIS Operations Coordinator~~ is CAPCOG's Project Representative, who is authorized to give and receive communications and directions on behalf of CAPCOG.
