2. Commission Percentage:

- a. Commission Percentage for the above existing vending machine locations will remain the same, fifteen percent (15%).

3. Vending Machine Choices:

- a. The general classification of items to be vended at the above locations may include some or all of the following:
 - i. Non-alcoholic Beverages;
 - ii. Candy/Gym;
 - iii. Snacks and Pastries;
 - iv. Other items agreed to by Williamson County Facilities Contracts Manager or designee.

Additional Vending Machines and Health Choice Options

Below are items that will be added to the contract and items that will be changed as a part of a pilot program to provide Vending Machine Health Choice Options.

1. Health Vending Machines Choices:

- a. The general classification of items to be vended at the following locations may include some of all of the following:
 - i. *35% healthy foods;
 - ii. Fruits;
 - iii. Snacks and Pastries;
 - iv. **Fresh food options;
 - v. Candy/gum;
 - vi. Canned food products;
 - vii. Non-alcoholic beverages; and
 - viii. other items agreed to by Williamson County Facilities Contracts Manager or designee after renewal is made.

* Health foods will be included in the overall food and beverage choices. These items will be determined by the vendor's expertise in determining popular choices, along with Williamson County Facilities Contracts Manager or designee. Nutritional information on these items should be posted either on the item itself or on a highly visible list on the machine.

- Williamson County Facilities Contract Manager or designee will make final decisions concerning which items will be made available at these two test site locations.
- Williamson County Facilities Contact Manager or designee will meet with McLiff quarterly to review sales, popular choices, alternate health options, and will maintain record of health options success and failures.

** Fresh Food Options, if options become available with McLiff, shall be placed in vending machines and must show the date of preparation in a conspicuous place on the wrapper. No item is to be placed in the machine after date has expired.
