Ms. Hancock,

This letter is requesting a price adjustment to our current Williamson County Contract T2526.

I have enclosed multiple letters and emails that we have received from some of our raw material suppliers. These documents show the increases in pricing that we are incurring for our thermoplastic as well as our water-based paint. With all of our combined increases, D.I.J.'s thermo costs will be up 41.5% from January 2021 to January 2022. This equates to an increase of \$0.06/lb of 4" thermoplastic. D.I.J. is requesting a price increase of 15% on all thermoplastic markings.

As noted in our previous paint invoice and the paint quote we have for 2022, our waterbased paint will increase in price an average of \$5.50/gallon. This equates to \$0.02/lb of 4". D.I.J. is requesting a 10% increase on all waterbased paint items.

Please note, D.I.J. is only asking for increases on the material costs and not including the increases in fuel and labor prices that we are incurring.
