NO. 7, effective as of the latest date of the signatories indicated at the conclusion of this document (the "Effective Date"), is made pursuant to the terms and conditions of the <u>Amended and Restated Agreement for Architectural and Engineering Services</u>, by and between **Williamson County**, **Texas** a political subdivision of the State of Texas ("County") and A/E.

RECITALS

WHEREAS, County and A/E previously executed <u>First Amended and Restated Agreement for Architectural and Engineering Services</u> being dated effective <u>November 24, 2020</u> ("Agreement");

WHEREAS, pursuant to **Article 3** of the Agreement, A/E may request additional time, which shall be subject to the approval of County; and,

WHEREAS, County now wishes to approve a requested time extension;

SUPPLEMENTAL WORK AUTORIZATION

NOW, THEREFORE, premises considered, County and A/E agree that **Work Authorization No. 7** is modified and amended as follows:

ARTICLE 1 SCOPE OF SERVICES

A/E and County hereby agree that no Additional Services are required.

ARTICLE 2 COMPENSATION FOR SERVICES

A/E and County hereby agree that no additional compensation is required.

ARTICLE 3 TIME FOR PERFORMANCE OF ADDITIONAL SERVICES

A/E hereby agrees to amend the Agreement Termination Date detailed in <u>Attachment C of Work Authorization 7 – Production Schedule</u> to 12/31/22.

ARTICLE 4 TERMS OF AGREEMENT & EXTENT OF SUPPLEMENTAL WORK AUTHORIZATION

All Additional Services described herein will be performed in accordance with the terms and conditions of the Agreement. All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, County has caused this Supplemental Work Authorization to be signed in its name by its duly authorized County Judge, thereby binding the parties hereto, their successors, assigns and representatives for the faithful and full performance of the terms and provisions hereof. OR MODIFY THIS AGREEMENT, EXCEPT PURSUANT TO SUCH EXPRESS AUTHORITY AS MAY BE GRANTED BY THE WILLIAMSON COUNTY COMMISSIONERS COURT.
