## Change Order No. 1 Reason for Change

This Change Order revises the pavement section within the US 79 TxDOT ROW to meet the requirements of TxDOT. TxDOT also made some adjustments to the signal phasing/timing for the new intersection at proposed US 79 and CR 401.
