And at said meeting, among other business, the Court considered the following:

**RESOLUTION**

WHEREAS, Judge Edna Staudt was first sworn into office of Justice of the Peace – Precinct Two in January 1995 and has since been re-elected seven times, faithfully serving the residents of Precinct Two for 28 years; additionally, she is a business woman, entrepreneur, mediator, mother of six, grandmother of 12, Christ follower, and trusted friend; and

WHEREAS, Judge Staudt has served on numerous civic, government and non-profit organizations boards, some of which include National Day of Prayer, Safe & Drug Free School Committee, Legacy Women's Republicans, Central Texas Justice of the Peace and Constables Association, County Bail Bond Board, and Chamber of Commerce's - Leadership Circle; and

WHEREAS, Judge Staudt strongly values human life and assisting with issues to improve the lives of children and youth, and has also served on boards for Texas Alliance for Life, Pregnancy Resource Center, Hope Connections, Agape Pregnancy Resource Center, Alan's Hope – Suicide Prevention Committee, Child Fatality Review Team and the Twin Lakes YMCA Advisory Board; and

WHEREAS, through her partnership with the Twin Lakes YMCA she was instrumental in development and overseeing the first Williamson County "Teen Court" that has been nationally recognized and allows youth to begin their adult lives without a criminal record; and

WHEREAS, through Judge Staudt's work on the Teen Court, she recognized that there was a need for more resources for struggling families and partnered with local businesses and ministries to create the Justice Court Mentoring Program that has helped hundreds of youth finish school, make positive choices, find employment, restore relationships, enter college and turn their lives around; and

WHEREAS, Judge Staudt has modestly accepted numerous awards, some include the Hill Christian Academy Leadership award, Hill Country Community Ministries – Heart of Hope Award, Central Texas JP & Constable Associations – Judge of the Year, and the Glen Shepherd Leadership Award; and

WHEREAS, through Judge Staudt's long career she has tirelessly worked with integrity and honor to improve communities in Williamson County and to make a positive impact to the lives of children, youth, and families.

NOW THEREFORE BE IT RESOLVED; that the Williamson County Commissioners Court would like to extend its appreciation to Judge Edna Staudt at her retirement for twenty-eight years of dedicated service to Williamson County and name the week of December 5<sup>th</sup> – 9<sup>th</sup> as "Judge Edna Appreciation Week".
