

## AMENDMENT

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. with offices at 5101 Tennyson Parkway, Plano, TX 75024 ("Tyler") and Williamson County, Texas, with offices at 710 Main Street, Ste. 101, Georgetown, TX 78626 ("Client").

WHEREAS, Tyler and the Client are parties to an agreement dated June 30, 2020 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

- As of the Amendment Effective Date, the Annual Estimate, as such term is defined in Exhibit E of the Agreement, for Client's summons/questionnaire production included with the Summons Direct service is hereby increased from 60,000 to 100,000 documents per year. The cost per summons is hereby decreased from \$0.56 to \$0.54, for a total annual recurring services fee of \$54,000.00, as set forth in the investment summary attached as Exhibit 1 to this Amendment.
- 2. Upon the Amendment Effective Date, Tyler shall invoice Client for the increase in fees for the current term in the amount of \$20,400.00, and payment shall be due thirty (30) days thereafter. Subsequent Summons Direct fees shall be invoiced annually in advance, in the amount of \$54,000.00, in accordance with the terms of the Agreement as modified by this Amendment.
- 3. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
