## RECITALS

WHEREAS, County and A/E previously executed that certain <u>Agreement for Design and Engineering Services</u> ("Agreement") being dated effective <u>December 6, 2022</u>, wherein A/E agreed to perform certain professional design and engineering services in connection with the Project;

**WHEREAS**, pursuant to **Article 20**, the terms of the Agreement may be modified by a written, fully-executed Contract Amendment;

WHEREAS, the parties wish to amend the language relating to Agreement Termination Date under Exhibit C of the Agreement; and,

**WHEREAS**, it has become necessary to supplement, modify and amend the Agreement in accordance with the provisions thereof.

**NOW, THEREFORE,** premises considered, County and A/E agree that the Agreement is supplemented, modified and amended as follows:
