Due to the existing utility conflicts impeding the remaining construction of this project, this Change Order will remove all remaining work contained in Phases 2 through 4 from the project.

This Change Order results in a net decrease of \$1,015,961.92 to the Contract amount, for an adjusted Contract total of \$12,160,165.73. The original Contract amount was \$11,526,789.09. As a result of this and all Change Orders to-date, \$633,376.64 has been added from the Contract, resulting in a 5.49% net increase in the Contract cost.
