SUPPLEMENTAL WORK AUTHORIZATION NO. 1 TO WORK AUTHORIZATION NO. 6

WILLIAMSON COUNTY ROAD & BRIDGE DEPARTMENT PROJECT: Chandler Corridor (SH 130 to CR 101, Segment 1

This Supplemental Work Authorization No. <u>1</u> to Work Authorization No. <u>6</u> is made pursuant to the terms and conditions of the Williamson County Contract for Engineering Services, being dated <u>May 19, 2020</u> ("Contract") and entered into by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and <u>Diamond Surveying</u> (the "Engineer").

WHEREAS, the County and the Engineer executed Work Authorization No. <u>6</u> dated effective <u>July 28, 2022</u> (the "Work Authorization");

WHEREAS, pursuant to Article 14 of the Contract, amendments, changes and modifications to a fully executed Work Authorization shall be made in the form of a Supplemental Work Authorization; and

WHEREAS, it has become necessary to amend, change and modify the Work Authorization.

AGREEMENT

NOW, THEREFORE, premises considered, the County and the Engineer agree that the Work Authorization shall be amended, changed and modified as follows:

- I. The Services to be Provided by the County that were set out in the original Attachment "A" of the Work Authorization are hereby amended, changed and modified as shown in the attached revised Attachment "A" (must be attached).
- II. The Services to be Provided by the Engineer that were set out in the original Attachment "B" of the Work Authorization are hereby amended, changed and modified as shown in the attached revised Attachment "B" (must be attached).
- III. The Work Authorization shall terminate on April 30, 2024. The Services to be Provided by the Engineer shall be fully completed on or before said date unless extended by an additional Supplemental Work Authorization. The revised Work Schedule is attached hereto as Attachment "C" (must be attached).
- IV. The maximum amount payable for services under the Work Authorization is hereby increased from \$32,850.00 to \$42,350.00. The revised Rate Schedule is attached hereto as Attachment "D" (must be attached).

Except as otherwise amended by prior or future Supplemental Work Authorizations, all other terms of the Work Authorization are unchanged and will remain in full force and effect.

This Supplemental Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.

<u>The Following Scope of Services is for One (1) Right-of-Way Acquisition Parcel – WCAD ID –</u> R474779 for Chandler Corridor, Segment 1

Scope of Services:

- 1. Preliminary Survey (one (1) R.O.W. Acquisition Parcel approximately proposed 12.1 acre tract of land): Perform office work necessary to research for current landowners per Williamson Central Appraisal District (WCAD) and record deed research and plots for Parcel to be acquired and existing right-of-way deeds for Chandler Road and SH 130 and prepare field packet for field crew to find and tie existing right-of-way monumentation. Field work necessary to find and tie boundary corners and existing right-of-way monumentation and visible above ground improvements along the project Route. Office work necessary to process, analyze and determine the existing right-of-way lines for Chandler Road and SH 130 and process points and line work for the improvements. Perform office work to prepare preliminary metes and bounds with sketch for use by Title Company for Commitment for Title Insurance for the tracts of land to be acquired. Location at the southeast corner of intersection of Chandler Road and SH 130. To include Surveyor preparing and sending Right-of-Entry form to landowner.
- 2. Final Survey (one (1) R.O.W. Acquisition Parcel): Perform office work to review Title Commitment (to be provided by Client) and address any easements or setbacks that may affect the subject tract. Prepare a Land Title Survey with metes and bounds description with sketch. Provide County with original signed and sealed paper copies for the Land Title Surveys. Perform field work to set appropriate monumentation for the right-of-way tract to be acquired.
