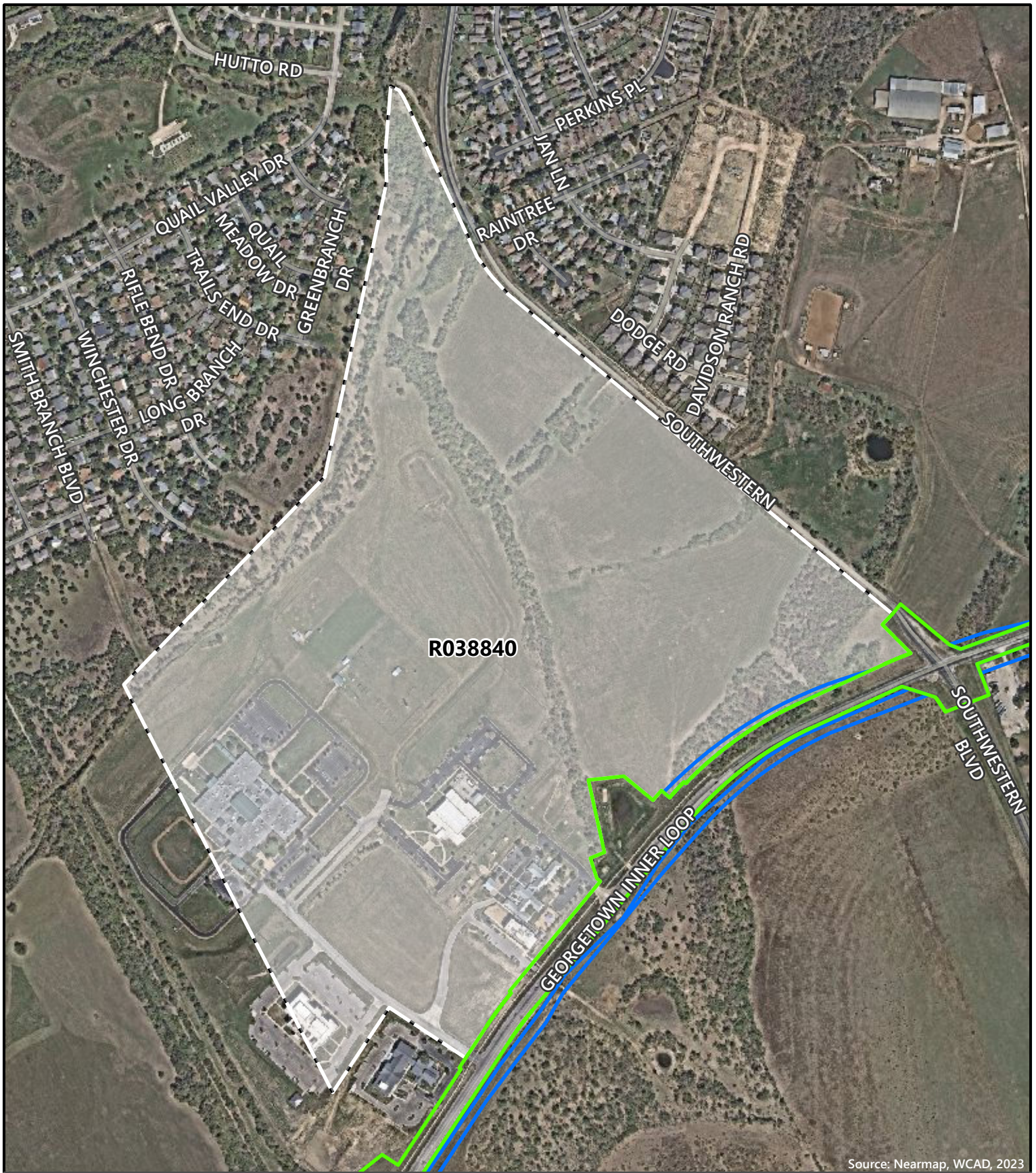

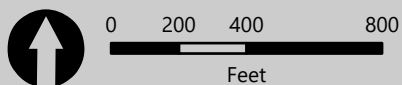


Southeast Inner Loop

Williamson County, Texas

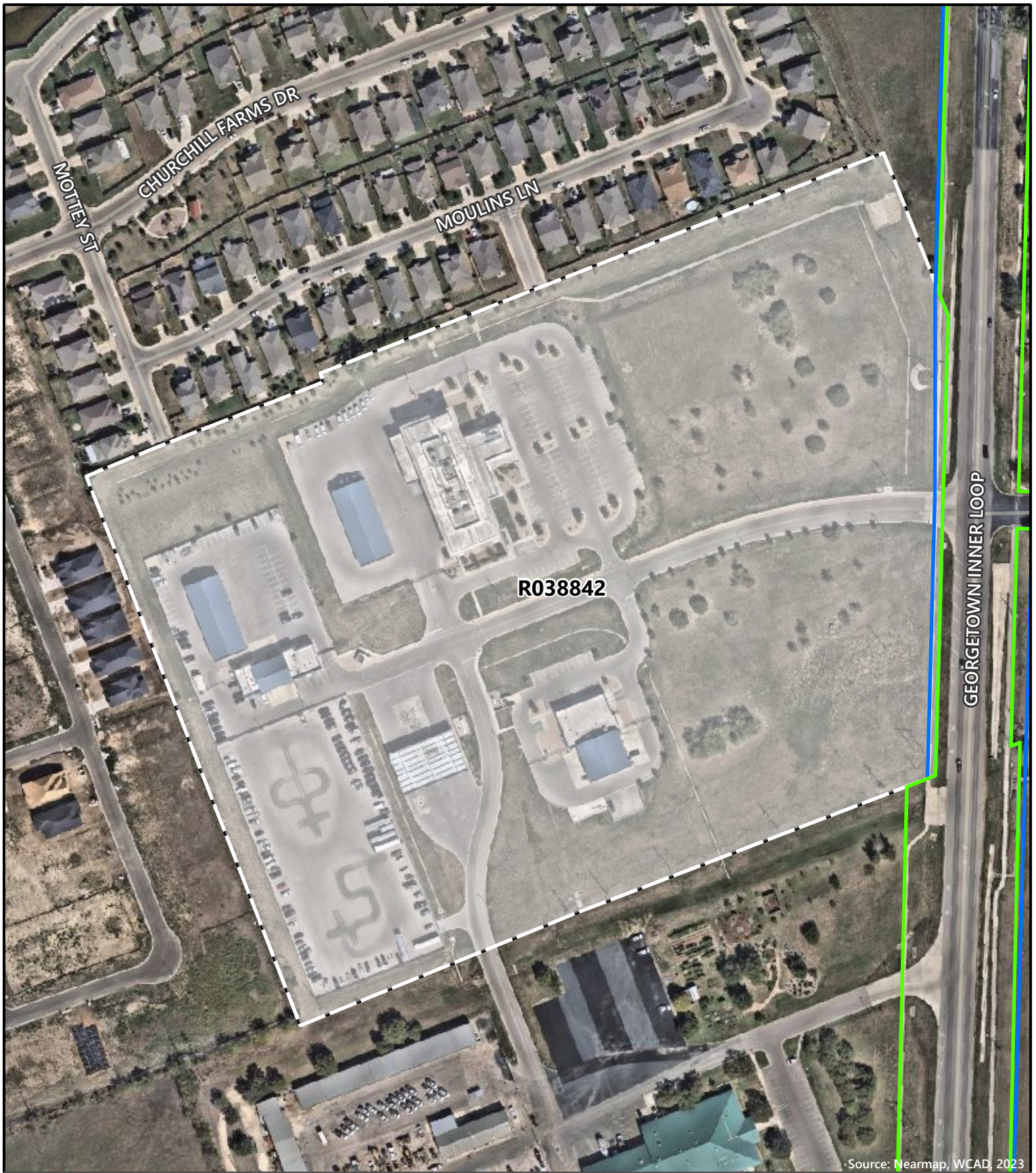


Parcel: R038840

 Proposed

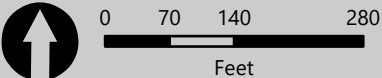









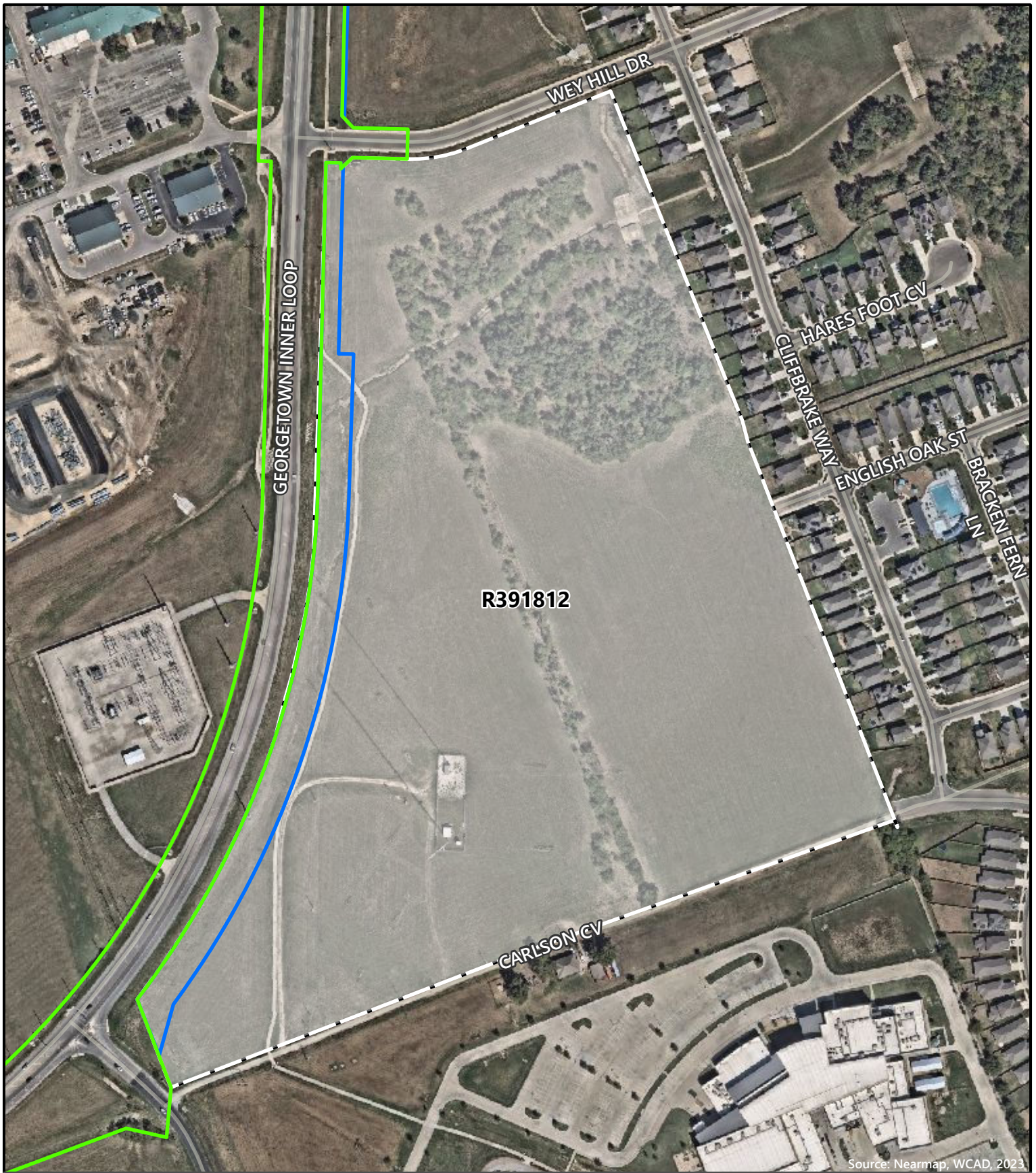

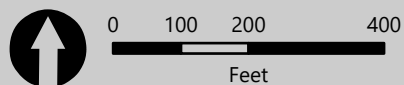



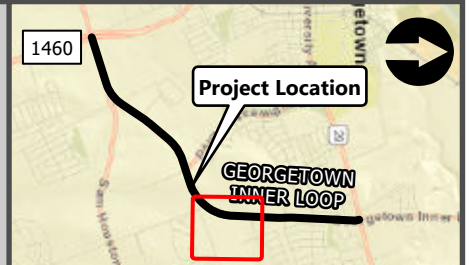

 Proposed

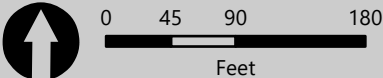
